Walking Frame Funding Criteria: This Guideline has been developed in consultation with expert clinicians and is designed to specify EnableNSW funding criteria for this group of assistive technology; items provided; eligible prescribers and provide a basis for consistent and transparent decision making.



Mobility: Walking Frame

EnableNSW funds the following self-care equipment. This list is not exhaustive and EnableNSW reserves the right to make the final decision regarding the provision of equipment that is not specifically included or excluded. Prescribers should check their eligibility to prescribe specific equipment in this category as identified in the table below

Request process:

- Items in this category are available through the Equipment Allocation Program (EAP) and the NSW Government Contract 963 Allied Health
- Prescribers are required to check and request suitable available items from the EAP website first.
- EnableNSW is required to order products from NSW Government Contracts. Prescribers should request items from contract when unable to utilise the equipment from EAP.
- Non-contract products will only be purchased in the event that there are no items on contract or available through the EAP, to meet a person's specific clinical need. Prescribers should contact an EnableNSW Clinical Advisor to discuss.
- An itemised quote is required for non-contract items requested.
- A prescriber cannot also be a supplier or affiliated with the supplier of the equipment for the same request. This may include but is not limited to a personal or
 professional relationship with or material interest in the supplier or manufacturer of the equipment listed on the request.
- EnableNSW provides the most cost effective item to meet a person's clinical need
- Only equipment that complies with the relevant Australian or International Standards and/or has Therapeutic Goods Administration (TGA) registration (class 1 medical devices) is funded.
